The reader might consider it incomprehensive, unsatisfactory, and even insufficient. This is indeed a gap that this author admits with a sense of remorse. Two reasons may explain this gap. First, it is an endeavor made in the initial stage. Second, the author couldn't get access to the

sources of data maintained in other libraries of the Saudi Kingdom and even outside. This is prepared on the basis of scanty literature and pertinent bibliographical sources that were available at the Central Library, King Abdulaziz University, Mecca Al-Mokarrama. All in all, it stresses the need of recording published materials of minorities not specified in this bibliography. Likewise, it impresses upon the reader the need to fill the gap mentioned above.
