Jihad, although misconstrued at times, is a struggle towards good. It does not necessarily mean War. Our Jihad is towards Peace. It can come in two ways, through force or through the pen. We opted for the latter.

According to a friend, if one takes the course of force, he must be prepared to be hit by it in return. In like manner, those choosing the other course, that of the pen, must be prepared to be hit by it as well.

With this book, we might be "penned" as undesirables, outcasts, or even criminals. We will not "pen back" because one purpose of this work is merely to relate an untold story. It is not intended to malign anything or anybody; only to awaken people to realities.

Our appointments as Commissioners of the Regional Consultative Commission for Muslim Mindanao provided us the opportunity to serve as middlemen between the Protagonists of the Mindanao Problem — the beneficiaries and the benefactors of the autonomy being crafted. This work, therefore, is based on a first hand information about the uncovered feelings of these protagonists — the formers' eagerness to receive and the latters' selfishness to give.

The Commission was a replica of the interplay among the actual forces involved in the resolution of the Problem. What we witnessed gave us a perspective clearer than any illustration of the situation conveyed by the voluminous literature written on the subject. Our role now is how to impart what came before our eyes. Conscience dictates that we perform such role.

There is a need to document the workings of the Regional Consultative Commission for Muslim Mindanao since the efforts of the Members are noble in purpose, and the Government emphasizes the "transparency" of its programs. Whatever such efforts contribute to the initiative of the different sectors of society towards PEACE hinges on the perception of both the law-makers and the protagonists of the so-called Mindanao Problem on the developments that occur day in and day out.

This volume is intended to be a feedback to the officials of the National Government for consideration in the conceptualization and the implementation of policies vis-a-vis the Muslims in the Philippines. On another level, the Muslims have to take cognizance of the weaknesses they show while the Problem is being considered for resolution. Both the National Government and the Muslims contribute to the complication of the Problem, and only by shunning from such adverse roles can the nagging Muslim Problem in the Philippines be put to rest.

The Authors wish to acknowledge the assistance extended by those who made possible the publication of this modest work. Here is hoping and praying for an eventual reign of Peace in Muslim Mindanao.

Through circumstances beyond our control, our efforts in the RCC were seemingly put to naught. This book explains how and why. Since we failed to contribute significantly to our history as a united people, we are then settling for this story to tell!
