ACKNOWLEDGMENTS

This study would never have been conceived, much less completed, without the assistance of friends, colleagues, and teachers in the United States and Indonesia. First, I must thank the faculty of the Department of Anthropology at the University of Illinois, who, for nearly fifteen years, served as teachers and friends. Lawrence W. (Larry) Crissman introduced me to anthropology and Asian studies at a time when I thought "Java" was a somewhat outdated slang expression for coffee. Clark Cunningham, Edward Bruner, and R. T. Zuidema taught me much of what I know about Indonesia and introduced me to the Dutch tradition of Javanese studies. Dimitri Shimkin was the first to encourage my studies of classical Islam; since he is not an Indonesianist, his thinking is free from the traditional view that Islam is of little importance in Javanese religion.

This study has also benefited greatly from conversations with fellow students at Urbana. Among those from whom I have learned the most are John Earls, John Gatewood, Ann Hill, John Lowe, John Morrison, Momodu Sarr, Susan Russell, Juliane Schober, and James Zeidler. I owe a special debt to Juliane Schober for numerous observations concerning the structural patterns of Southeast Asian states and the complexities of the "court/village axis."

Three graduate students at Arizona State University provided much-needed assistance in producing the final manuscript. Kim Dettmer and Elizabeth Allen struggled with several rather unuser-friendly computers to convert a typescript into computer files and files into typescript.

Leah Mangkubumi Gohier from the Surakarta court read portions of the manuscript and made many valuable suggestions. My Middle Eastern Muslim students constantly encouraged me to "go back to the Qura'n and Hadith" to discover what they feel to be the "true Islam." The sometimes heated debates among them in classes on Sufism and Islamic civilization have been a constant reminder of the diversity and complexity of Muslim discourse.

Frank Reynolds of the University of Chicago Divinity School encouraged my studies of Hindu, Buddhist, and Islamic textual traditions. Largely due to his influence I consider myself as much a historian of religion as an anthropologist. Richard Martin, Fred Denny, and Richard Eaton read portions of an early version of the manuscript and offered invaluable suggestions concerning the Islamic textual tradition and the local Islams of South Asia and the Middle East.

Clifford Geertz allowed me to examine the manuscript of his book *Negara* prior to its publication. He was also kind enough to comment on several chapters of this text. Although this study is a critique of Professor Geertz's *Religion of Java*, it also was inspired by it. While I have many disagreements with Geertz's analysis of Javanese Islam, *Religion of Java* was one of the many books I took with me to Yogyakarta, and one of the few that helped me in my research.

Special thanks are due to F. K. Lehman. Kris was my teacher (in almost the Javanese sense of the word) for nearly fifteen years. Most of what I know about anthropology I learned from him. He was also the first to insist on the value of being an orientalist as well as an anthropologist. He has, more than any other person, influenced the direction my research has taken.

The fieldwork on which this study is based was made possible by grants from the Institute for International Education, the Graduate College Research Board, and the Department of Anthropology at the University of Illinois. Archival and textual research was supported by the Social Science Research Council and the Center for Asian Studies at Arizona State University.

In Indonesia I was the guest of the Indonesian Academy of Sciences (LIPI) and the Akademi Seni Karawitan Indonesia in Surakarta. I am grateful to the staffs of both these distinguished institutions for their support, advice, and encouragement. Dr. Parsudi Suparlan of the University of Indonesia pointed out numerous gaps in my data and helped me to clarify my thinking concerning the structural logic of Javanese Islam. I am also indebted to Professor Koentjaraningrat of the same institution for his comments concerning the Javanese theory of power and for his published studies of Javanese culture and religion.

I owe my greatest debt to the people of the sultanate of Yogyakarta. Among the many who helped me and tolerated my endless questions, several stand out.
