In this profound and original work, embracing a wide area of research, the author treats first with the position of the Muslims in China and the relations between the Chinese and Muslim populations cast in terms of majority-minority groups and host-guest cultures. Secondly, and against that background, there is an analysis of the 18th and 19th century developments in China which led to the rise of Muslim secessionism and the outbreak of Muslim rebellion; this part is more solidly anchored in historical documentation and provides an interesting historical approach to that important period of Muslim-Chinese relations. It can fairly be claimed that no other work has attempted to present an analysis and record of such an important yet neglected topic, and thus it breaks into fresh ground in this area of Sinological and Islamic studies.
